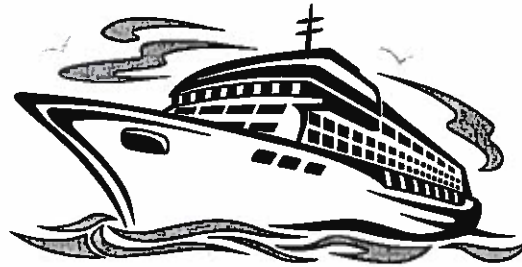

Our Itinerary:

Wednesday, Oct. 3

Depart by motorcoach from New London and East Lyme to New York for our flight to Honolulu, Hawaii. On arrival we are transferred to the Sheraton Princess Kaiulani, located in the heart of Waikiki for our 3 night stay including daily American breakfast.

Thursday, Oct. 4 Honolulu

The capital of Hawaii, Honolulu is a unique and vibrant city, we have a morning departure for our 6 hour city tour including Pearl Harbor Arizona Memorial and Punchbowl. There is Hawaiian entertainment poolside every evening at our hotel.

Friday, Oct. 5 Honolulu

Day at leisure, spend your day soaking up the sun on Waikiki Beach or at the freshwater pool at the hotel, or take an optional tour to the Polynesian Cultural Center.

Saturday, Oct. 6 Honolulu

We have most of the day to enjoy before we transfer from our hotel to the pier to board NCL's Pride of America for our 7pm sailing for 7 days visiting the Hawaiian neighbor islands.

Sunday, Oct. 7 –Monday, Oct. 8 Kahului, Maui

Arrive at 8am for our 2 day stay, many things to do; visit historic Lahaina, take a whale watch cruise, Plantation tour, snorkel with the turtles or travel to the top of massive Haleakala Volcano crater.

Tuesday, Oct. 9 Hilo, Hawaii

Arrive at Hilo at 8am until 6:00pm, the largest of the Hawaiian Islands. You can walk through the Botanical Gardens where there is over 2000 species of fragrant tropical flowers, fruits and plants. Another option is to explore Volcanos National Park; home of Kilauea, the most active volcano in the world.

Wednesday, Oct. 10 Kona, Hawaii

In Kona from 7am until 5:30pm. Spend your day at Anaehoomalu Bay famous for the black sand beaches or take in zodiac raft adventure and snorkeling hopefully seeing dolphins. Of course the world famous Kona coffee or macadamia nut treats are available to purchase.

Thursday, Oct. 11- Friday, Oct. 12 Kauai

Arrive Kauai at 10am for overnight stay. Known as the "Garden Isle" you can take a train trip through tropical gardens or visit Waimea Canyon. For the more adventurous, there is tubing through a tropical waterway or try a zipline tour soaring over the rainforest.

Saturday, Oct. 13 – Honolulu

Too soon we are back in Honolulu for our transfer to the airport for our overnight flight home.

Sunday, Oct. 14

Arrive New York where our motorcoach awaits to return us to East Lyme and New London.
