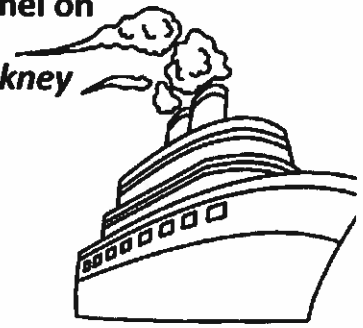




## ***Escape winter February 3 to 17, 2019***
